This includes these program areas as well as general support, anti-violence work, and support work in prisons. The geographic focus is the Dallas, Texas, region, with incarceration support extending across Texas.

Approximately 8 volunteers provided about 57 hours of service for this program, and staff volunteered almost 1600 hours. For the year, approximately 780 letters were received, and approximately 570 responses were sent. Staff volunteered over 1,000 hours of additional time to various other prison services tasks, including significant time to documenting and preparing comment letters concerning PREA audit deficiencies and preparing a report on PREA noncompliance in Texas (published in January 2026). TPI also supported a volunteer to attend a prison issues conference during the year.

clients address housing and healthcare issues (about 40 hours), and provided general education and movement building work (about 35 hours). in guiding persons into affirming healthcare, helping guide and connect with housing providers, provided advice and guidance in employment issues (including guidance on addressing discrimination), provided assistance in updating identity documents, and supported work on external education efforts and trans equality movement building. Most of this work was undertaken on a volunteer basis by the organization president, who donated about 60 hours during the year to these specific tasks.
